## ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

### SUMMARY

#### Net Proceeds from the Share Offer

Based on the Offer Price of HK\$0.30 per Offer Share and 215,000,000 Offer Shares, the net proceeds from the Share Offer to be received by the Company, and after deducting the underwriting commission and fees and other estimated expenses payable by the Company in relation to the Share Offer, are estimated to be approximately HK\$13.6 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future Plans and Use of Proceeds” in the Prospectus.

#### Public Offer

- The Public Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. A total of 8,974 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and by giving **electronic application instructions** to HKSCC via CCASS and through the **HK eIPO White Form** Service Provider under the **HK eIPO White Form** Service for a total of 1,841,800,000 Public Offer Shares, representing approximately 85.67 times of the total number of 21,500,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to the over-subscription in the Public Offer, the reallocation procedures as described in the paragraph headed “Structure and Conditions of the Share Offer — Public Offer — Reallocation” in the Prospectus have been applied. As the number of Offer Shares validly applied for in the Public Offer represents more than 50 times but less than 100 times of the number of Offer Shares initially available under the Public Offer, 64,500,000 Shares have been reallocated to the Public Offer from the Placing, so that the total number of Offer Shares allocated to the Public Offer has been increased to 86,000,000 Offer Shares, representing 40% of the total number of Offer Shares initially available under the Share Offer.

## **Placing**

- The Placing Shares initially offered under the Placing have been slightly over-subscribed. A total of 232,600,000 Placing Shares have been subscribed for, which is equivalent to approximately 1.20 times of the total number of 193,500,000 Placing Shares initially available under the Placing. The final number of Placing Shares allocated to 161 placees under the Placing is 129,000,000 Placing Shares after reallocation to the Public Offer, representing 60% of the total number of Offer Shares initially available under the Share Offer. A total of 91 placees have been allotted 5 board lots of Shares or below, representing approximately 56.5% of the total number of placees under the Placing. These placees have been allotted 1.42% of the Placing Shares under the Placing. A total of 81 placees have been allotted 2 board lots of Shares or below representing approximately 50.3% of the total number of placees under the Placing. A total of 22 placees have been allotted one board lot of Shares, representing approximately 13.7% of the total number of placees under the Placing. These placees have been allotted 0.17% of the Placing Shares under the Placing.
